Athletic Waiver & Release of Liability

In consideration of being permitted to use Ice Station Valencia (hereinafter "Ice Station") and to participate in any Ice Station athletics/sports program and related activities, the undersigned participant, and parent or legal guardian if the participant is a minor, (hereinafter "releasor(s)"):

1. Agrees to inspect Ice Station Valencia and any Ice Station Valencia equipment to be used prior to use or participation. If any Ice Station facility or equipment is found to be unsafe by the Releasor(s), the Releasor(s) shall immediately notify Ice Station of the unsafe condition and refuse to use the unsafe facility or equipment. If any athletics/sports program or activity is found to be unsafe by the Releasor(s), the Releasor(s) shall immediately notify the program or activities coach or supervisor of the unsafe condition and refuse to participate in the program or activity. It is the duty of the Releasor(s) to provide all personal equipment and protective devices and to maintain such equipment and items in proper condition.
2. Acknowledges and fully understands that the athletics/sports programs or activities to be engaged in involve risk of serious injury, including permanent disability and death and severe social and economic losses that may result not only from their actions, inactions or negligence, but also the action, inaction or negligence of others, the rules of play, or the condition of the facility or of any equipment used. Furthermore, there may be other risks not known to or reasonably foreseeable at the time of use or participation.
3. Knowing of the foregoing risks, the Releasor(s) agree to assume those risks and accept personal responsibility for all damages following such injury, permanent disability or death.
4. Releases, waives, discharges and covenants not to sue Ice Station, its affiliated clubs, their administrators, directors, agents, coaches, or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, the owners and leasees of premises used to conduct the program or activity, (all of which are hereinafter referred to as "Releasees"), from any and all liability to the Releasor(s), their heirs and assignees for any and all claims, property damage, caused or alleged to be caused in whole or in part by the negligence of the releasees.
